# Legislative Report Skee Dodson, State Legislative Officer, Texas Abate Confederation, Inc.

The Texas 86<sup>th</sup> legislative session is now history, and as noted in previous articles.... We overwhelmingly defeated the mandatory helmet bill – HB 748, filed by Rep. Neave of D-107. What most riders didn't realize, was that if this bill had passed, it would have set Texas back at least 40 years in motorcycle rights legislation! Texas ABATE considers our last legislative session a success, and we remain a "freedom of choice state"!

Unfortunately, Texas bikers had little luck introducing a motorcycle profiling bill this legislative session. Motorcycle profiling in Texas, since May 2015 (Waco massacre) has reached epidemic levels (Motorcycle Profiling Project - MPP). Texas is #2 in the Nation for reported motorcycle profiling (2018 MPP survey). Many legislators tend to agree that profiling is going on, and many argue that profiling is unconstitutional; however, a vast majority of lawmakers are concerned that bringing awareness to profiling would take away some of the "tools" that law enforcement have available to them (wait, what?). It is time for a different mindset in our judicial system, and it is time for Texas to come up with some legislative relief! This legislative session may be over, but Texas freedom fighters are already looking forward to the 87<sup>th</sup> legislative session in 2021!

Talk about bringing awareness to Texas profiling, did you hear that the San Antonio police were citing individuals for wearing MC colors in public –stating that it is a crime? I'm embarrassed that this happened in Texas, but I'm not surprised. In July of 2019, members of a local motorcycle club were cited for "disturbing the peace" – only for displaying their cuts in public (public display of "gang" colors). I can't make this stuff up; read about it here:

The courts already recognize that our 1st amendment rights protect freedom of expression. Moreover, as Double D points out in the article above, "wearing motorcycle club colors is not reasonable suspicion of a traffic infraction or criminal activity, which is the minimal threshold for a seizure under the 4<sup>th</sup> Amendment". The **Texas Council of Clubs & Independents (COC&I)** urges all bikers to report any violations, or motorcycle profiling, that you may encounter - preferably with videos (which can be critical to cases like the one above). **Ride, Record, Report!** Texas ABATE also has a Facebook link to report mc profiling at <https://www.facebook.com/TexasABATELegislative>.



On, or about, August 24<sup>th</sup> of 2019 the "disturbing the peace" case was dismissed. As defense attorney Milly Thompson stated in a letter addressed to San Antonio law enforcement: "Someone needed to explain the First Amendment to the officer that issued the citation." The First Amendment protects our freedom to associate, regardless how popular it is with law enforcement. Presently, we have a federal bipartisan house resolution, H.Res. 255, that addresses motorcycle profiling. This Motorcycle Anti-Profilng Resolution will promote awareness of profiling and encourage communication between law enforcement and the motorcycling community. The US Senate passed an identical resolution last session - by unanimous consent! Contact your U.S. house representatives, and ask them to support this bill by co-sponsoring it. The Motorcycle Riders Foundation (MRF) makes it easy to take action with a link on the MRF website - and it only take a minute. Take action here:

## All Politics are Local (continued from previous publication) Nasty, Asst. Coordinator, Arlington

Let's see, in local education they are picking the Superintendent, local bond committee, boundary committee, and, my personal favorite, The Financial Futures Committee. Money, taxes, those who have the gold – make the rules. I did them all. As a member of the financial committee, we were tasked with advising how to make up a 25-million-dollar gap in the following year's budget. This is in a very austere district. I, personally, made successful initiatives to defer a half million dollars in Football uniform purchases. With another member and the Transportation Director, devised a way to hold off millions of needed bus purchases by offsetting School starting times to utilize the existing fleet more efficiently. We managed to reduce the shortfall, as a group, to about ten million. That exhausted all our options, which was 6 cents per thousand-dollar assessment. That was the most we could raise it without triggering putting it on the local ballot. Not popular. Remember, I did this myself. Talk about personal impact.

This is just one of the many examples I can give you. You can do so much as an individual, that impacts all of us directly, with little time commitment. Most of us, thanks to our training and support of ABATE, are ready. In addition, what does it look like if a bunch of Bikers show to a meeting of suits? An army. Bum rush them. It works! When they need experts on our issues, guess who they go to? US! That's who. Real power, folks.

I, along with some others, have successfully used Ol' Tip's words, and made it work for us. Even if issues don't go our way, we go on record in dissent. That's influence, too. But that's another article.
