Legislative Report Skee Dodson, State Legislative Officer, Texas Abate Confederation, Inc.

Thank you, Texas ABATE, for sending me to Indianapolis, Indiana, for the 36th Annual Motorcycle Riders Foundation' (MRF) Meeting of the Minds - Hoosier style! What an exhaustive & productive weekend it was; from the opening remarks, the general session, the legislative update, and the MRF Champions and Membership awards - this 36th annual Meeting of the Minds, hosted by ABATE of Indiana, was awesome! Good job volunteers, and congrats to all award

recipients! Texas ABATE received a recognition award for the "Largest Outreach Via Call to Action to House Transportation Committee Members During Debate on the Highway Bill"; long title, but a very meaningful accomplishment by everyone who took action! Texas ABATE would not have had the "largest outreach" if it were not for the advocacy of all Freedom Fighters in Texas, including ABATE! The MRF managed to get 4 (4.5) motorcycle amendments included in this bill (HR 2). Since this Transportation Bill passed the House, it will not have to be re-introduced in this chamber again next session – and that is going to make the MRF legislatively stronger to get the Senate to follow suit.



The "Federal Legislative Strategy Session" on Saturday afternoon established our 2021 high and medium priority objectives – as well as the objectives the MRF is monitoring. INNOCENT BIKER'S PERSISTENCE NETS NEW HARLEY

The Texas biker may have deserved a speeding ticket, but he didn't think the traffic stop warranted the questioning, roadside investigation, pat-down search, or enduring an hour of detainment along the roadway waiting for a drug-sniffing dog to arrive on the scene; resulting in inconvenience and embarrassment because a law enforcement officer had guessed wrong.

Statistically, police are terrible at determining which motorists are worthy of being detained and searched, often relying on signs of a driver's deception such as twitching, fidgeting or lack of eye-contact, all of which research long has debunked as signals of lying.

"There are no nonverbal and verbal cues uniquely related to deceit," a 2011 review of deception research concluded, while a 2005 study of Texas police found officers performed barely above random chance in being able to discern a person telling the truth from a liar.

Texas police performed just under a million searches during traffic stops last year, according to figures reported to the Texas Commission on Law Enforcement, and though "hit rates" vary by department, only about 1 in 5 resulted in contraband being found. Yet Texas law enforcement agencies seized about \$50 million in forfeited funds in each of the past five years; with proceeds split between police and prosecutors and used to fund more searches.

Police once needed probable cause that a crime was occurring to investigate motorists during a stop. But in 1968, the U.S. Supreme Court allowed brief stops based on a lower standard of "reasonable suspicion" of wrongdoing. A later decision clarified that if the officer can't specify why

- HB 646 - Relating to the operation and inspection of mopeds.
- HB 3131 - Relating to the classification and operation of mopeds and certain motorcycles
- SB 486 - A new light-duty motor vehicle powered by an electric drive is eligible for a \$2,500 tax incentive

DID NOT ADVANCE (BILLS WE SUPPORTED):

- SB273 - Relating to the operation and movement of motorcycles on certain highways during periods of traffic congestion (lane sharing).
- HB 1270 - Relating to the operation and movement of motorcycles on certain highways during periods of traffic congestion (lane sharing).
- HB 4265 - Relating to the rules of the road regarding red signals at certain traffic-control signals.

DID NOT ADVANCE (BILLS WE OPPOSED):

- HB 748 - Universal Helmet bill authored by Rep Neave, HD 107 HB 748 - was totally inappropriate for Texas riders; 64% of motorcycle riders in Texas already wear a helmet. We need to promote education in our state, not more legislation. (Texas ABATE had a petition ready with 2000+ signatures of Texas freedom fighters that choose to stand with liberty. This petition was not utilized, as this bill never made it to a hearing.) HB 748 had 25% progression, 1 co-sponsor, and died in the Transportation Committee.

OTHER NOTEWORTHY ACCOMPLISHMENTS FOR TEXAS FREEDOM FIGHTERS:

- Oct 2019 - TCOC&I confront Texas VFW in Austin to question General Orders 2019-2020, which included inappropriate motorcycle profiling language (motorcycle gangs, vests, etc. prohibited). Commander King promptly removed this statement.
- Progress in being made with our statewide COC&I motorcycle "RideRecordReport" campaign - to report motorcycle profiling.
- Texas ABATE attended the Texas Senate Sunset Advisory Board hearing in 2019-and testified for our Motorcycle Safety Funds.
- Texas ABATE filed with the State Audit Board requesting investigation of the misappropriated spending by the TXDPS-misappropriating millions of dollars from our 0501-motorcycle safety fund (case still pending).
- Gov Abbott proclaimed May as Motorcycle Safety & Awareness month in Texas - in both 2019 and 2020.
- 2016-2019 Texas riders participated each year in the Annual MRF Bikers Inside the Beltway (Texas to DC).

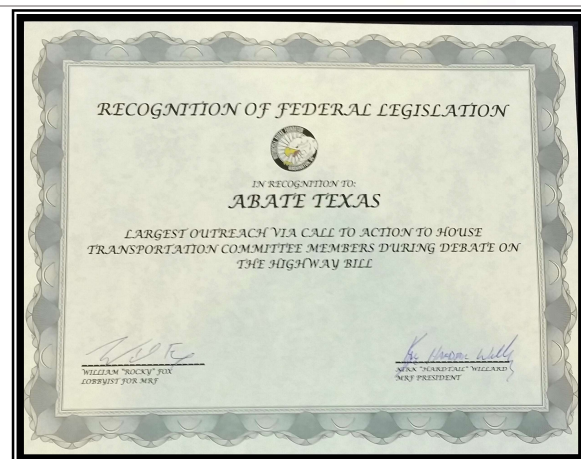

he suspects a crime is afoot, a traffic stop may last only long enough to check the driver's paperwork and write a ticket or warning.

Most recent national analyses of traffic stops have focused on the disproportionate rate of police searches of Black and Hispanic motorists, though a federal measure currently under consideration in Congress could add motorcycle riders to that profiling study group.

And so, this biker was relieved to finally be allowed on his way with just a ticket, but knew it wasn't right and figured his motorcycle club vest must have raised the officer's suspicions.

Innocent people rarely protest meritless searches, so finding an attorney to take his case was difficult. The overwhelming number of legal challenges occur in suppression hearings, when an officer's suspicions were correct; contraband was discovered, and the defendant seeks to have the evidence tossed on procedural grounds.

With the help of an Austin attorney who represents motorcyclists, the angry biker filed a lawsuit against the Texas trooper in early 2019. Soon after reviewing the dashcam video, lawyers for the Texas attorney general's office said they were ready to settle.

According to the story posted in Insane Throttle (www.HarleyLiberty.com), the two sides agreed on \$11,000 to compensate wronged rider Thomas Kost for the unjustified intrusion, and he used the settlement money to buy a new Harley.

The Texas biker may have deserved a speeding ticket, but he didn't think the traffic stop warranted the questioning, roadside investigation, pat-down search, or enduring an hour of detainment along the roadway waiting for a drug-sniffing dog to arrive on the scene; resulting in inconvenience and embarrassment because a law enforcement officer had guessed wrong.

Statistically, police are terrible at determining which motorists are worthy of being detained and searched, often relying on signs of a driver's deception such as twitching, fidgeting or lack of eye-contact, all of which research long has debunked as signals of lying.

"There are no nonverbal and verbal cues uniquely related to deceit," a 2011 review of deception research concluded, while a 2005 study of Texas police found officers performed barely above random chance in being able to discern a person telling the truth from a liar.

Texas police performed just under a million searches during traffic stops last year, according to figures reported to the Texas Commission on Law Enforcement, and though "hit rates" vary by department, only about 1 in 5 resulted in contraband being found. Yet Texas law enforcement agencies seized about \$50 million in forfeited funds in each of the past five years; with proceeds split between police and prosecutors and used to fund more searches.

Police once needed probable cause that a crime was occurring to investigate motorists during a stop. But in 1968, the U.S. Supreme Court allowed brief stops based on a lower standard of "reasonable suspicion" of wrongdoing. A later decision clarified that if the officer can't specify why

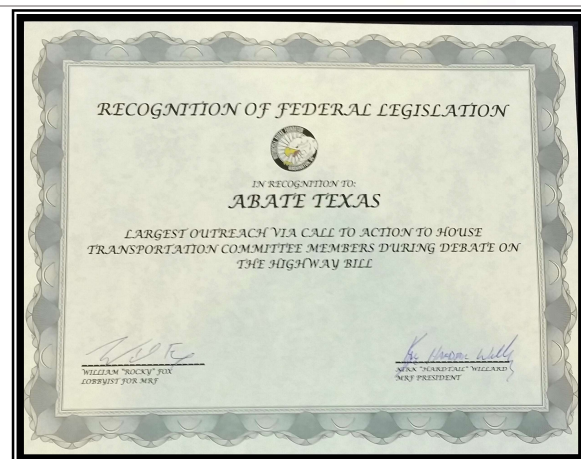

he suspects a crime is afoot, a traffic stop may last only long enough to check the driver's paperwork and write a ticket or warning.

Most recent national analyses of traffic stops have focused on the disproportionate rate of police searches of Black and Hispanic motorists, though a federal measure currently under consideration in Congress could add motorcycle riders to that profiling study group.

And so, this biker was relieved to finally be allowed on his way with just a ticket, but knew it wasn't right and figured his motorcycle club vest must have raised the officer's suspicions.

Innocent people rarely protest meritless searches, so finding an attorney to take his case was difficult. The overwhelming number of legal challenges occur in suppression hearings, when an officer's suspicions were correct; contraband was discovered, and the defendant seeks to have the evidence tossed on procedural grounds.

With the help of an Austin attorney who represents motorcyclists, the angry biker filed a lawsuit against the Texas trooper in early 2019. Soon after reviewing the dashcam video, lawyers for the Texas attorney general's office said they were ready to settle.

According to the story posted in Insane Throttle (www.HarleyLiberty.com), the two sides agreed on \$11,000 to compensate wronged rider Thomas Kost for the unjustified intrusion, and he used the settlement money to buy a new Harley.

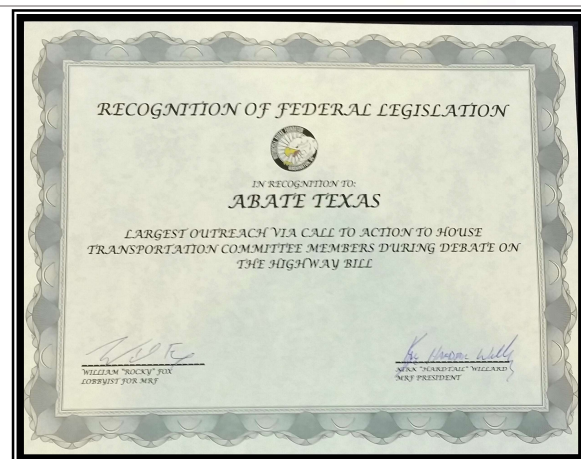

Innocent people rarely protest meritless searches, so finding an attorney to take his case was difficult. The overwhelming number of legal challenges occur in suppression hearings, when an officer's suspicions were correct; contraband was discovered, and the defendant seeks to have the evidence tossed on procedural grounds.

With the help of an Austin attorney who represents motorcyclists, the angry biker filed a lawsuit against the Texas trooper in early 2019. Soon after reviewing the dashcam video, lawyers for the Texas attorney general's office said they were ready to settle.

According to the story posted in Insane Throttle (www.HarleyLiberty.com), the two sides agreed on \$11,000 to compensate wronged rider Thomas Kost for the unjustified intrusion, and he used the settlement money to buy a new Harley.

What an exhaustive & productive weekend it was; from the opening remarks, the general session, the legislative update, and the MRF Champions and Membership awards - this 36th annual Meeting of the Minds, hosted by ABATE of Indiana, was awesome! Good job volunteers, and congrats to all award

recipients! Texas ABATE received a recognition award for the "Largest Outreach Via Call to Action to House Transportation Committee Members During Debate on the Highway Bill"; long title, but a very meaningful accomplishment by everyone who took action! INNOCENT BIKER'S PERSISTENCE NETS NEW HARLEY

The Texas biker may have deserved a speeding ticket, but he didn't think the traffic stop warranted the questioning, roadside investigation, pat-down search, or enduring an hour of detainment along the roadway waiting for a drug-sniffing dog to arrive on the scene; resulting in inconvenience and embarrassment because a law enforcement officer had guessed wrong.

Statistically, police are terrible at determining which motorists are worthy of being detained and searched, often relying on signs of a driver's deception such as twitching, fidgeting or lack of eye-contact, all of which research long has debunked as signals of lying.

"There are no nonverbal and verbal cues uniquely related to deceit," a 2011 review of deception research concluded, while a 2005 study of Texas police found officers performed barely above random chance in being able to discern a person telling the truth from a liar.

Texas police performed just under a million searches during traffic stops last year, according to figures reported to the Texas Commission on Law Enforcement, and though "hit rates" vary by department, only about 1 in 5 resulted in contraband being found. Yet Texas law enforcement agencies seized about \$50 million in forfeited funds in each of the past five years; with proceeds split between police and prosecutors and used to fund more searches.

Police once needed probable cause that a crime was occurring to investigate motorists during a stop. But in 1968, the U.S. Supreme Court allowed brief stops based on a lower standard of "reasonable suspicion" of wrongdoing. A later decision clarified that if the officer can't specify why

- HB 646 - Relating to the operation and inspection of mopeds.
- HB 3131 - Relating to the classification and operation of mopeds and certain motorcycles
- SB 486 - A new light-duty motor vehicle powered by an electric drive is eligible for a \$2,500 tax incentive

DID NOT ADVANCE (BILLS WE SUPPORTED):

- SB273 - Relating to the operation and movement of motorcycles on certain highways during periods of traffic congestion (lane sharing).
- HB 1270 - Relating to the operation and movement of motorcycles on certain highways during periods of traffic congestion (lane sharing).
- HB 4265 - Relating to the rules of the road regarding red signals at certain traffic-control signals.

DID NOT ADVANCE (BILLS WE OPPOSED):

- HB 748 - Universal Helmet bill authored by Rep Neave, HD 107 HB 748 - was totally inappropriate for Texas riders; 64% of motorcycle riders in Texas already wear a helmet. We need to promote education in our state, not more legislation. (Texas ABATE had a petition ready with 2000+ signatures of Texas freedom fighters that choose to stand with liberty. This petition was not utilized, as this bill never made it to a hearing.) HB 748 had 25% progression, 1 co-sponsor, and died in the Transportation Committee.

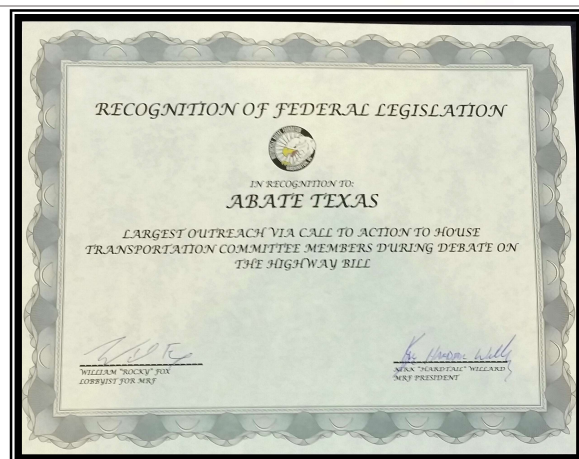

he suspects a crime is afoot, a traffic stop may last only long enough to check the driver's paperwork and write a ticket or warning.

- Texas COC&I, moving forward, will be known as the "Texas Council of Clubs and Independents" (dropping all affiliation with AIM).
- Texas Governor Greg Abbott proclaims May as Motorcycle Safety and Awareness Month for another consecutive year!
- NHTSA released info in 2019 that Texas, Motorcycle Fatalities dropped 15%-the lowest number of fatalities in over a decade! (Nationally, motorcycle fatalities dropped 5%.)
- Texas Legislature only meets every other year (odd years)
- January 12, 2021 is the first day of the Texas 87th legislative session; and our "Texas Biker Legislative Day 2021" -on January 25th - at the State Capitol in Austin!



TEXAS 86TH LEGISLATIVE SESSION (2019)

BILLS ADVANCED (BILLS WE SUPPORTED):

- SB 616 - moving the administration of the mc training course and the administration of the 0501- motorcycle safety fund away from the Department of Public Safety (TX DPS)-and moving all administration to the [Texas Department of Licensing and Regulation \(TDLR\)](#). Effective Sept. 1, 2020.
- HB 1755 - Relating to assembled vehicles and former military vehicles, including the titling and registration of those vehicles.

INNOCENT BIKER'S PERSISTENCE NETS NEW HARLEY

The Texas biker may have deserved a speeding ticket, but he didn't think the traffic stop warranted the questioning, roadside investigation, pat-down search, or enduring an hour of detainment along the roadway waiting for a drug-sniffing dog to arrive on the scene; resulting in inconvenience and embarrassment because a law enforcement officer had guessed wrong.

Statistically, police are terrible at determining which motorists are worthy of being detained and searched, often relying on signs of a driver's deception such as twitching, fidgeting or lack of eye-contact, all of which research long has debunked as signals of lying.

"There are no nonverbal and verbal cues uniquely related to deceit," a 2011 review of deception research concluded, while a 2005 study of Texas police found officers performed barely above random chance in being able to discern a person telling the truth from a liar.

Texas police performed just under a million searches during traffic stops last year, according to figures reported to the Texas Commission on Law Enforcement, and though "hit rates" vary by department, only about 1 in 5 resulted in contraband being found. Yet Texas law enforcement agencies seized about \$50 million in forfeited funds in each of the past five years; with proceeds split between police and prosecutors and used to fund more searches.

Police once needed probable cause that a crime was occurring to investigate motorists during a stop. But in 1968, the U.S. Supreme Court allowed brief stops based on a lower standard of "reasonable suspicion" of wrongdoing. A later decision clarified that if the officer can't specify why

- HB 646 - Relating to the operation and inspection of mopeds.
- HB 3131 - Relating to the classification and operation of mopeds and certain motorcycles
- SB 486 - A new light-duty motor vehicle powered by an electric drive is eligible for a \$2,500 tax incentive

DID NOT ADVANCE (BILLS WE SUPPORTED):

- SB273 - Relating to the operation and movement of motorcycles on certain highways during periods of traffic congestion (lane sharing).
- HB 1270 - Relating to the operation and movement of motorcycles on certain highways during periods of traffic congestion (lane sharing).
- HB 4265 - Relating to the rules of the road regarding red signals at certain traffic-control signals.

DID NOT ADVANCE (BILLS WE OPPOSED):

- HB 748 - Universal Helmet bill authored by Rep Neave, HD 107 HB 748 - was totally inappropriate for Texas riders; 64% of motorcycle riders in Texas already wear a helmet. We need to promote education in our state, not more legislation. (Texas ABATE had a petition ready with 2000+ signatures of Texas freedom fighters that choose to stand with liberty. This petition was not utilized, as this bill never made it to a hearing.) HB 748 had 25% progression, 1 co-sponsor, and died in the Transportation Committee.

OTHER NOTEWORTHY ACCOMPLISHMENTS FOR TEXAS FREEDOM FIGHTERS:

- Oct 2019 - TCOC&I confront Texas VFW in Austin to question General Orders 2019-2020, which included inappropriate motorcycle profiling language (motorcycle gangs, vests, etc. prohibited). Commander King promptly removed this statement.
- Progress in being made with our statewide COC&I motorcycle "RideRecordReport" campaign - to report motorcycle profiling.
- Texas ABATE attended the Texas Senate Sunset Advisory Board hearing in 2019-and testified for our Motorcycle Safety Funds.
- Texas ABATE filed with the State Audit Board requesting investigation of the misappropriated spending by the TXDPS-misappropriating millions of dollars from our 0501-motorcycle safety fund (case still pending).
- Gov Abbott proclaimed May as Motorcycle Safety & Awareness month in Texas - in both 2019 and 2020.
- 2016-2019 Texas riders participated each year in the Annual MRF Bikers Inside the Beltway (Texas to DC).

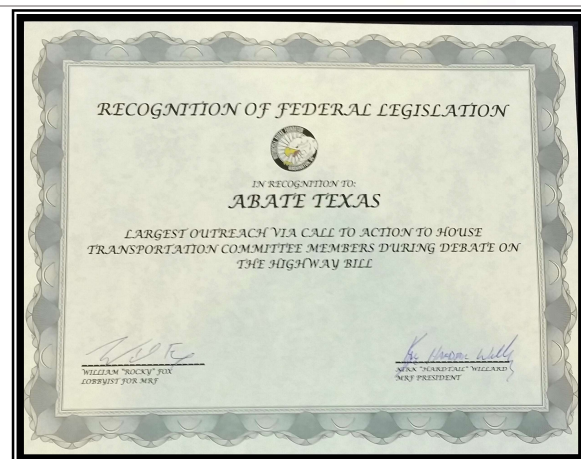

he suspects a crime is afoot, a traffic stop may last only long enough to check the driver's paperwork and write a ticket or warning.

Most recent national analyses of traffic stops have focused on the disproportionate rate of police searches of Black and Hispanic motorists, though a federal measure currently under consideration in Congress could add motorcycle riders to that profiling study group.

And so, this biker was relieved to finally be allowed on his way with just a ticket, but knew it wasn't right and figured his motorcycle club vest must have raised the officer's suspicions.

Innocent people rarely protest meritless searches, so finding an attorney to take his case was difficult. The overwhelming number of legal challenges occur in suppression hearings, when an officer's suspicions were correct; contraband was discovered, and the defendant seeks to have the evidence tossed on procedural grounds.

With the help of an Austin attorney who represents motorcyclists, the angry biker filed a lawsuit against the Texas trooper in early 2019. Soon after reviewing the dashcam video, lawyers for the Texas attorney general's office said they were ready to settle.

According to the story posted in Insane Throttle (www.HarleyLiberty.com), the two sides agreed on \$11,000 to compensate wronged rider Thomas Kost for the unjustified intrusion, and he used the settlement money to buy a new Harley.
